General Counsel Joel Merkel provided an update on the status of the King County's ordinance 18403 imposing a "rental charge" on utilities for use of the public right of way for their distribution facilities. As reported in June, Paul Bay and Directors from five other coop or non-profit utilities that serve members in Council District 3 scheduled a Zoom meeting with District 3 King County Council member Sarah Perry to ask that she support an audit of the effectiveness of Ordinance 18403 and that she support holding a hearing by the full Council to repeal the Ordinance. The meeting was limited to Board members of the utilities, i.e. no attorneys for the utilities were involved. Paul took the lead in drafting an issue paper for the Board members summarizing the problems created by the Ordinance which were raised and discussed at the meeting to send to Ms. Perry.

# H. NEW BUSINESS

1. Reinstatement of the NRECA RS Plan & 401(K) Plans

The Retirement Security (RS) Plan and 401(k) Pension Plan follow a five-year restatement schedule outlined by the Internal Revenue Service (IRS). The plans were last restated in 2017; therefore, in 2022 TEC must review, approve and re-adopt plan provisions.
